Honoree: Dr. Russell L. Ackoff



Russell L. Ackoff is the Anheuser-Busch Professor Emeritus of Management Science, the Wharton School, and Distinguished

Affiliated Faculty, Center for Organizational Dynamics, both at the University of Pennsylvania. He has served as a visiting professor at The National Autonomous University of Mexico, The University of Birmingham (UK), Lisbon University and Washington University (St. Louis). He received a B. Arch. in 1941 and a Ph.D. in Philosophy of Science (1947) from the University of Pennsylvania (Penn). He served in World War II from 1942 to 1946. Prior to retirement from Wharton in 1986, he was Chairman of the Social Systems Science Department and Director of The Busch Center for Systems Research.

Ackoff authored twenty-three books, the most recent of which are *Idealized Design*, with Jason Magidson and Herbert J. Addison

(Wharton, 2006), *Beating the System* with Sheldon Rovin (Berrett-Kohler, 2005), *Redesigning Society* with Sheldon Rovin (Stanford University Press, 2003), *Re-Creating the Corporation* (Oxford, 1999), *Ackoff's Best* (Wiley 1999), and *The Democratic Corporation* (Oxford, 1994). He has also published more than 200 articles in books and journals.

A charter member and former president of the Operations Research Society of America, founding member and former vice president of the Institute of Management Sciences, and former president of the Society for General Systems Research, he has received six honorary degrees and a number of medals. He has been elected a member of both the Academy of Natural Sciences for the Russian Federation and The International Academy of Management. The Ackoff Center for the Advancement of Systems Approaches was established at the University of Pennsylvania in 2001. His work in research, consulting, and education has involved more than 350 corporations and 75 government

Sam joined WCF as President/CEO in March 2009. Sam's career has many facets – congressional candidate, businesswoman, community

leader, and now President of WCF. In 2008, Sam ran one of the most successful challenger campaigns for Congress in Pennsylvania's 15th district. A first time congressional candidate, she garnered national attention with her fundraising skills and won the endorsements of several national organizations including: the Women's Campaign Forum, Democratic Congressional Campaign Committee, and EMILY's list. Though ultimately losing her

race to incumbent Charles Dent, she obtained more votes than any other Democratic candidate in the district's history. Sam first ran for political office in 2001, when she nearly defeated long-time state senator Roy Afflerbach in the Allentown mayoral race – losing by only 46 votes. In addition to her political pursuits, she also currently serves as the Statewide Director and CEO of Properties of Merit of PA, Inc., a non-profit organization that works to spur citizen involvement and “bottom-up” private and public investment in the critical work of revitalizing communities. Now a 20-year resident of Allentown, Pennsylvania, Sam is married to a computer professional and has three children; a seven-year-old son, and two college-age daughters.

Honoree: Walter Kee, Jr.


Barbara Flanagan Memorial Education Award Winner

Andrea Lawful-Trainer is an extraordinary educational consultant who has made broad impact on closing academic achievement

gaps across the Delaware Valley. Mrs. Trainer conducts tailored workshops and delivers motivational speeches in a way that engages and empowers. Demand for services of the organization she founded in 2003, Children And Parental Enrichment Services (C.A.P.E.S) has sky rocketed due to the success of her work.

The mother of two young boys in Abington, Pennsylvania, Mrs. Trainer became involved in the daily lives of children served by the Abington School District upon learning of patterns of inequity. Having been taught from childhood that education is powerful, she embarked on a journey to learn the educational system in a twenty week program called Parents As Leaders that teaches the importance of being able to advocate for children. She was so empowered by what she learned that she became a trainer for the program and began taking that knowledge to parents in other districts including Cheltenham, Springfield Township and North Penn school districts as well as the Mastery Charter in the Delaware Valley. She carries the torch for the program originators.

Andrea created the Committed Advocates Leading Many (C.A.L.M.) Society an organization of adults that ensures all children have access to a quality education while empowering parents to work with school districts to provide an environment that leads to the best possible outcome for all children.

Andrea's active involvement as a Student Advocate led to a successful run for the Abington School Board in 2007 where she currently serves as one of nine members of the Board of Directors. She is the past President of Abington School District's Parent Council and has served on several community organizations including; the Abington Community Taskforce, Citizens and Police together, Abington Human Relations Advisory Council, Local Tax Study Commission, State Parent Advisory Council, The Governor's Institute for Parental Involvement and a Policy writing committee in Harrisburg. She is a current Board member of the Abington YMCA and a Centers For Progressive Leaders 2009 Fellow. She is also working with Dr. Bob Jarvis from the Delaware Valley Minority Student Achievement Consortium on the creation of a Parent Taskforce.

Mrs. Trainer has an undergraduate degree in Communications and a Post Graduate Degree in Education.

Remembering: Gary Papa

Gary Papa went to Cornell University as an undergraduate, and actually considered a career as an attorney. He even earned his law degree at

the University of Buffalo Law School.

He went into television in Buffalo, and in Steubenville, Ohio. In April 1981, Gary Papa came to Action News and the Delaware Valley. Gary's first report was from Milwaukee, where the Sixers were playing the Bucks in the NBA playoffs.

\Gary spent 9 years as weekend sports anchor, working alongside Rob Jennings. He also spent 3 days a week reporting from the field, often on the Phillies, Flyers, Sixers and Eagles, and often on ordinary people doing extraordinary things.

Action News wasn't Gary's only program here on Channel 6. He was also the host of the long running weekend show Prime Time, taking over from Jim O'Brien in 1983.

In 1990, Gary was named Action News Sports Director. Where ever the sports story was, whenever it took place, Gary was there. So when the Eagles were playing on Sundays, he was working. And if they were on the road, so was he.

And when sports came to town, even sports that we weren't all familiar with, Gary was there, and he explained them to all of us.

Because he was seemingly everywhere, seemingly all of the time, many Action News viewers considered Gary part of their families, as did all of us who worked with him.

So when Gary announced on air in 2004 that he was battling prostate cancer, he knew he was sharing a private ordeal with people who cared, and he received an outpouring of emotion and support throughout his fight.

And for Gary it was a powerful fight. In fact, for much of that fight he was on top, but three years later, he broke the news to all of us, that he was again undergoing chemotherapy.

Through it all, Gary's love was being on air every night he could. When he sat in the studio, no matter how awful he felt, his spirit would brighten, his smile would shine, and, if even for just 3 minutes, he felt the joy and the thrill of sharing the day's sports, and being part of the day's triumphs and tragedies with all of you, and with all of us.

Gary left behind his wife Kathleen, his two sons Tucker and Nathaniel, of course his Action News family, and all of you.

Honoree: Vernon Price

a tribute by J.D. Hugarir, Director, Psych M/U, Philadelphia

I met Vernon when he called the Mobile Unit to assist him with a neighborhood situation where a chronically mentally ill person was living on the street. She was aggressively panhandling, approaching passers-by and people stopped in their cars and demanding money. Shopkeepers and residents of the neighborhood had become fearful of her behavior.

Vernon was approached by the committee-person for whom he worked and was asked to find a resolution to this problem.

Vernon recognized that the woman was sick and contacted me. After five or so days of trying to find the least restrictive disposition for this woman, she was finally petitioned for in-patient hosp.

Vernon shows the insight to see what is needed in the many and varied situations he comes in contact with,

calling in the people who not only deal with the short-term solutions but help plan for the long-term, to hopefully prevent recurrences of the event.

He keeps in touch with what is going on in the Mt. Airy area, working with the business community, neighborhood organizations, the Police and individuals who need help negotiating the sometimes difficult road to get things done in this political climate.

I see his approach as low key, but no nonsense and he works until the situation is resolved.

I feel that Vernon deserves this award because of his dedication to the community and his attitude of not seeking the limelight for the things that he does, taking satisfaction in helping others and making the community a better place for everyone.

Special Guest: Congressman Joe Sestak



Joe Sestak was elected to Congress in 2006 to represent the 7th Congressional District where he was born and raised. During a distinguished

31-year career in the United States Navy, Joe attained the rank of 3-star Admiral and served in the White House, Pentagon, and in operational commands at sea. He is the highest-ranking former military officer ever elected to either branch of Congress. He attended the Naval Academy and later earned a Ph.d. in Political Economy and Government from Harvard University. After retiring from the Navy, Joe returned home to Delaware County, Pennsylvania, with his wife, Susan, and daughter, Alex, and proudly represents the 7th District, where his parents and much of his family still reside.

Joe is the son of a first-generation American who served his country as a Navy Captain in World War II. Following in his father's footsteps, Joe went to Annapolis, where he graduated second in his class, before embarking on a career of military service. He served as Director for Defense Policy in President Bill Clinton's National Security Council, oversaw the Navy's warfare budget as Deputy Chief of Naval Operations, and led a series of commands at sea, culminating in command of the USS George Washington Aircraft Carrier Battle

Group (30 ships, 100 aircraft, and 15,000 sailors and marines) during combat operations in Afghanistan and Iraq. In our time of national crisis in the immediate aftermath of 9/11, the Navy turned to Joe Sestak to head "Deep Blue," the Navy anti-terrorism unit formed in response to the attacks.

Since taking office in 2006, Joe has been named the most productive member in his legislative class. He is one of the few representatives to serve on three committees, serving as Vice Chair of the Small Business Committee, and a member of the Committee on Education and Labor and the Armed Services Committee. In the current Congress he has had more of his bills pass than either of the state's two Senators, and is among the top five members of Congress in the number of bills and resolutions he has co-sponsored – a record of achievement that is unsurpassed in the entire Pennsylvania delegation, House and Senate. At home in Pennsylvania, his district office has handled over 10,000 constituent cases over the past two years – more than three times the average – and his staff has helped more than 400 of his constituents avoid foreclosure on their homes.

Honoree: Jonathan Justin Taylor



Jonathan Justin Taylor is Director of Administration for Wildfire Commerce, Inc. His responsibilities include MIS deployment

and support, business process development and a myriad of other duties associated with running the Wildfire Commerce office.

Educated at Durham Community College and Duke University,

Jonathan is fluent in both English and Spanish. He very freely gives his time and extensive experience helping many people navigate the extremely complex and difficult processes associated with becoming a U.S. citizen. He has been devoted to this effort for many years and is currently working with several individuals in the tri-state area assisting them with their immigration concerns. Jonathan does not expect nor receive compensation for this work. It is his way of giving back and always looking out for those in need.

Honoree: Dennis Zappone Commissioner, Abington Township

I have helped people all my life starting out in the 1970's as a volunteer on an ambulance crew in West Oak Lane in Philadelphia. I have volunteered my time at my parish helping the kids with computer training and also assisting with the annual carnival.

In 1996 Abington Township was hit with a flood and that flood happened to be in Ardsley, my community. I helped a friend with clean up as well as other neighbors. I was then approached by the civic association to run for commissioner, and I did. I had so much strong support from my neighbors it made me feel good and I wanted to carry over that good in a positive way and that was helping my community with their many problems.

Over my 10 years span as commissioner I helped many people with township matters as well as personal matters. I guess my mentor was Jon Fox. I strive to respond to community issues like he did when he served as Congressman and state rep. I tend to go out of my way to help my seniors, and appreciate their hard work and labors when they were coming up through this community.

It's time we pay them back. When one of my seniors call I stop by and visit them, they simply love that their Commissioner took time out of his busy schedule to sit with them, they deserve it. I want nothing in return but the fact that they are happy. Their problems become my problem.

Honorees: Seth Williams, Esq.



Seth Williams grew up in a hard-working West Philadelphia neighborhood, the only child of Imelda Williams and the late Rufus

O. Williams. After graduating from Central High School in 1985, Seth attended Penn State University where he served as President of the Black Caucus and later as President of the Undergraduate Student Government. Seth went on to law school at Georgetown University, where he graduated with distinction as a Public Interest Law Scholar in 1992.

After graduation Seth's dedication to public service brought him home to Philadelphia, where he joined the District Attorney's Office. In the ten years he served as an Assistant District Attorney, Seth was repeatedly promoted, including his appointment as the Assistant Chief of the Municipal Court, where he supervised the 30 newest prosecutors. He also created and led the Repeat Offenders Unit with the goal of reducing the high percentage of crimes committed by repeat offenders. His extensive trial experience includes 37 jury trials, more than 1,500 bench trials and more than 2,500 felony preliminary hearings.

In 2005, Seth challenged Lynn Abraham, Philadelphia's longtime incumbent District Attorney, in the Demo-

cratic primary. While not victorious on Election Day, Seth won 46 percent of the vote.

After the election, he was appointed Inspector General of the City of Philadelphia, responsible for investigating all allegations of corruption, fraud, waste, abuse and employee misconduct among municipal workers and companies doing business with the city.

Seth went on to take a position as counsel at the Center City law firm of Stradley, Ronon, Stevens & Young.

Seth continues to serve his community as an educator and volunteer. He is an adjunct professor at Neumann College in the Strategic Leadership Master's Program and is an adjunct professor and Advisory Board member at Penn State Abington. Seth is also a Major in the Judge Advocate General Corps of the United States Army Reserve.

Seth serves on the boards of several community organizations, including the Catholic Social Services of the Archdiocese of Philadelphia, the Overbrook Park Civic Association and Town Watch, St. Cyprian Catholic Church, the St. Martin de Porres Foundation and the West Philadelphia Y.M.C.A.

Seth lives in West Philadelphia with his wife Sonita and is the proud parent of three girls, Alyssia, Taylor and Hope.

Honorees: Jean & Tony Wrice

Jean Wrice, born in Philadelphia in 1939, is the wife of the late great Anti-drug Activist leader, Dr. Herman Wrice. She helped her mother raise her six brothers and sisters.
